Purpose of the Register

The purpose of the register is to act as the customer data register of Streamec UK branch. The data can be used for the following uses:

- Order processing and delivery
- Billing and payment transactions
- Production and development of services
- Marketing

Regular sources of information

The main source of information is the customer her/himself. Information can also be obtained from public authorities, publicly available internet searches, business registers and joint partners.

Content of the Register

The register mainly contains information provided by customers to Streamec UK branch.

The register may include e.g. the following customer information:

- The name of the person
- Company name and ID
- Email address and phone number
- Postal, billing, and bank details
- Service and user settings
- Product and service order information
- Other customer information required by the Services

Regular disclosures

With the customer's consent, the information may be disclosed to the joint partners of the customer and Streamec UK branch for the delivery of the products and services ordered by the customer.

The billing information can be passed on to the payment intermediary.

Data will not be disclosed to other third parties inside or outside the EU.

Information may be disclosed to the authorities if they submit a request under UK law.

Principles of data protection of Register

Manual material

Data will not be stored as physical items, except for records that are only accessible to certain Streamec AB and/or UK Branch employees and accountants who are bound by confidentiality.



Data stored in data management systems

The data is transferred over an SSL secure connection.

Electronic data is protected by a firewall. Only designated Streamec AB and/or UK Branch employees have access to register information. Employees are identified with a username and password. The information is treated as confidential and may not be disclosed to anyone other than those who are bound by the obligation of professional secrecy.

Inspection and Prohibition Right

The data subject has the right to check what information about him / her has been stored in the customer data register and the right to ask us to correct, update, change or the remove the personal data at any time. However, please note that certain information is strictly necessary in order to fulfill the purposes defined in this Statement and may also be required by law. Thus, such personal data may not be removed. A written request for verification must be sent to the person in charge of the register.

The right of inspection is free of charge up to once a year.

Data retention time

We will retain personal information only for the time necessary to reflect the type of personal data and the purpose for which they are processed.
